The sealed Limited Tender of items/financial bid will be opened on **05.11.2015 at 04.00 p.m.**
3. The IGIPESS reserves the right to reject partly or fully the supply in case, the items supplied against any indent is not according to samples/specimen approved. The number and quantity of items to be purchased may be increased/decreased. In all matters of dispute, the decision of the Principal, IGIPESS, shall be final.
4. Your quoted rates to the item/s should be valid upto **31.03.2016** If you are a manufacturer of the quoted item/s, a certificate to that effect should be attached along with the quotation/s.
5. An earnest money of **2% of the estimated cost i.e. Rs.22,200/- (Twenty Two Thousand Two Hundred only)** by demand draft in favour of the "PRINCIPAL, IGIPESS" is required to be attached along with your sealed quotation.
6. No mark of Supplier's name should be printed on the sample of Sports Goods. Each item as display must have coding, which should match with the coding given in Financial Bid/Quotation.
