Indira Gandhi Institute of Physical Education & Sports Sciences (University of Delhi), Block-B, Vikaspuri, New Delhi-110018 had applied for seeking recognition of existing course of Post Graduate Diploma in Physical Education (One Year) in the proper application form in NRC office on 17.05.1997.

AND WHEREAS, the matter was considered by NRC and as per decision of NRC recognition was granted to the institution vide NRC order No. F-3/DH-01/Phy.Ed./2000 5380-57 dated 31.07.2000 for Post Graduate Diploma in Physical Education of Two Year from the academic session 2000-2001 with an annual intake of 50 seats subject to fulfilling the certain condition.

AND WHEREAS, The matter regarding change of nomenclature of the course was placed before the NRC in its 189th meeting held on 24th to 28th November, 2011. The committee discussed and considered the case in detail and following observation have been made:

- As per the request of the Principal, Indira Gandhi Institute of Physical Education and Sports Sciences, New Delhi and as per the direction of the NCTE Hqrs. New Delhi, NRC, NCTE has decided to change the nomenclature of P.G. Diploma in Physical Education to B.P.Ed.

Now therefore, In view of above, the nomenclature of P.G. Diploma in Physical Education is being changed to B.P.Ed.
